Dear Applicant:

The Ridgewood YMCA has a financial assistance program for the Y's Kidz and Camp Pamacka summer day camps. Our financial assistance program is composed of camp tuition scholarships and scheduled payment plans based on need and availability.

Each year, the demand for this assistance grows. Because we have a commitment to serve as many children as possible and maximize the number of opportunities we can provide, we have established the following guidelines.

- Applicants are required to complete the enclosed application forms, and submit the documentation specified in the application. (If submitted incomplete, the application will be returned.)
- A decision based on need for financial assistance will be made within two weeks of April 5 and, if accepted by the applicant, a mutually agreed-upon payment schedule will be instituted.
- Scholarships are based on a financial sliding scale up to 60% of tuition.
- All payments to be made by cash, credit card, or check and all fees must be ***paid in full two weeks prior to each session's enrollment***. **Failure to adhere to this schedule will result in termination of child's participation in the camp program.**
- Each camper registration requires a \$100 weekly deposit, payable by check, cash or credit card.
- **NOTE: Applications are due no later than April 5th.**
