PARENT / GUARDIAN AND YMCA AGREEMENT

Deposits: A deposit of \$100 per camp week, per camper with a \$25 deposit per extended hours is due at registration. Balance must be paid in full at least 2 weeks (10 business days) prior to the campers first start date. Deposit or full payment must accompany registration in order to complete registration.

Refund Policy: All camp week deposits and program enrollment fees are non-refundable. A \$25 processing fee will be charged for all refund requests. Cancellations submitted at least 2 weeks (10 business days) prior to your campers first camp date will receive a 50% refund (minus deposit, program enrollment fee, and refund processing fee). No refunds will be allowed within 2 weeks (10 business days) of the start of your camper's session. If your child is absent from camp for medical reasons for five consecutive days, we will attempt to place your child in another camp week or will issue a credit voucher. A physician's note will be required. There will be no credits issued for vacations, incidental absences, transportation delays or dismissals from camp.

Discipline Policy: I will review and reinforce the camper conduct and other camp policies (available in Ridgewood YMCA parent guide) with my child prior to the start of camp. Discipline at the Y is handled with redirection and positive reinforcement to help children understand proper behavior. Campers not following the conduct policy may be suspended or expelled from camp with no refund.

Late Pick Up Fees: We maintain our camper-to-staff ratios for extended hours and it is therefore critical that campers be signed out per their registration status. Day camps end at 4:00pm, parents/guardians who are late picking up campers and who are not registered for extended hours will be charged a fee of \$25 per camper, per day after 4:10pm. Extended hours ends at 6:00pm, there is a \$25 late fee for any camper signed out after 6:10pm.

Photography Policy: The Y reserves the right to use any and all photographs and videos taken of my child in camp activities in YMCA promotional material.

Liability Policy: No insurance has been included in membership or camp fees. I further agree to indemnify and hold harmless the Ridgewood YMCA from any claims or demands arising out of any such injuries and losses.
